Thank you for your prompt response, the last thing I knew was that the police advised me that the records including my mothers were being forwarded to the GMC and I would be contacted, nobody has ever contacted me. The police advised me that there may have been medical negligence, but nothing criminal. Due to the loss of my father at the time that the police advised me they were no longer investigating this and one year earlier the loss of my brother I did not have the strength to continue with this, but it is still very painful when this is on the TV.

Are you able to advise me how the 10 families were picked for the inquest and why others have been excluded, even though I have not pursued this I was under the impression that all the deaths would be involved in the inquest when it happened especially those that were classed as a higher rating with the police. Do you also have a telephone number at the GMC that I can call to find out what happened to my mothers case.

Once again thank you for your assistance.
