She was nursing the elderly before Barton came on the scene, and says they never used opiates before Barton, or syringe-drivers. She also speaks of formal complaints by herself, and Nurses Giffin and Tubritt about the unnecessary use of opiates, and being labelled trouble-makers. She also mentions correspondence and minutes she has retained from the time.

Clearly an important witness.

Would it not be appropriate to ask the coroner to call Giffin and Tubritt as well (or maybe he already has, since I don't have the total package with me), even though they do not appear to have been involved with my step-father?

Also, to ask for the mentioned correspondence and minutes to be made available.
