It's 12.46 and what

I've asked Mrs MACKENZIE to do now...I'm going to show Mrs MACKENZIE a copy of a Portsmouth Health Care Trust Heath Record relating to her mother, Mrs RICHARDS, and this is referenced LH1 and each of the pages has been accorded it's own reference number and I would invite Mrs MACKENZIE, if she makes a comment based on the Health Record, perhaps to refer to the page number as she does so. So the next voice you'll hear is Mrs MACKENZIE and off we go.

1.28 MACKENZIE

The first page I refer to is LH/1/C/7 which is the past medical history of my mother and I would make the comment, "Deaf in both ears", yes, but she could hear with the aid of a hearing aid but the Nursing Home had lost the hearing aid and hadn't replaced it. "Cataract operations in both eyes", yes, but she could see with one eye, with her glasses, but the Nursing Home had lost her glasses.

This is the Nursing Home at Lee-on-Solent?

At Lee-on-Solent, yes, and those details are in the Case Conference which was held by the Social Services Department into the Nursing Home. "Six month history of falls", yes, since she was put on tranquillisers Trizadone and Alaperidol. "Alzheimer's, worse over the last

six months", yes, if it was Alzheimer's, and I understand you can't be sure of that unless you do a post mortem on the brain. "Worse over the last six months", I would contend, due to dementia and the added risk of tardive dementia due to the two drugs in question. I would then refer to LH/1/C/8 which is a note by, I think, Philip BEAD, the Charge Nurse at the Gosport War Memorial, where he mentions that, in addition to the treatment i.e., drugs that Haslar had recommended, they had added 'Oramorph'. Why? Because she hadn't needed it in Haslar, why did she need it at the Gosport War Memorial Hospital? The next page, LH/1/C/9, a letter from Doctor R I REED. In his letter he has commented that her mobility has deteriorated over the last six to seven months, and I've just specified why I think that was, and that, according to her doctor, she has been 'knocked off' or 'knocked out' by this medication for months and has not spoken to them for six or to seven months. Well she has spoken, not long conversations, not always full sentences, but she certainly has spoken and has recognised who I was, although I'd come from Eastbourne, and I'd spent several visits down at the Nursing Home and certainly she knew who I He also mentions that, "Since they was.

stopped doing the trizodone we both thought she'd been much brighter mentally". I would say she'd been mentally more bright than she'd ever been in the last six months in the Nursing Home. He says, "Mrs RICHARDS was clearly confused and unable to give a coherent story". I would suggest that when you are questioning a lady who has dementia, and cannot hear a thing without a hearing aid, she is likely to be confused plus the fact she couldn't lip read because she hadn't got her glasses, "But she was however pleasant and co-operative". The next page, if you'll bear with me until I find it, LH/1/C/11, which I think are notes made by Doctor BARTON, dated the 11th of August, when she was transferred to Gosport from Haslar and Doctor BARTON has made a surprising statement, "I'm quite happy for the nursing staff to confirm death". There is no impression from Haslar that she was anywhere near death. Why should Doctor BARTON assume that she was going to die? The idea was that she should be about four to six weeks in Gosport before she was, for rehabilitation with her zimmer, before being sent on to another hospital. I don't see why she should be happy for staff to confirm death, if there was no need, unless she had already had it in her mind that

That is not correct. We were there at 9 o'clock in the morning and we had the conversation with Philip who told us nothing could be done. She had a massive haemetoma. The kindest way to treat her was to put her on Diamorphine to ease her pain until she died. "They agreed to use the syringe driver to control pain and allow nursing care to begin". Yes, we did agree the syringe driver. We were under the impression she was going to die within 24 hours.
