Paragraph 1

“Today, 3rd November 2009, we have come to Parliament to ask for justice for the victims who died at the Gosport War Memorial Hospital, Portsmouth, in the late 1990s because of the actions of Dr Jane Barton and the staff she fostered over a number of years. After 10 years of fighting, the true facts have still not yet come to light concerning the deliberate over-dosing with morphine and sedative drugs of vulnerable frail and elderly patients that led to their deaths within a few days of being admitted for care by the NHS.

Paragraph 4

"...nothing less than criminal prosecutions *against all those involved...*"

I just wondered what you thought to the second and third amendments suggested by the family. I am less sure about the first. I know what they mean because the nurses were involved too.

Your other changes looked fine.
