Welcome back. I hope you had a good holiday.

Mrs Mackenzie has had a long standing interesting in these two statements. As far as I know they are relevant to the administration of a tranquillizer (possibly chlorpromazine) which was associated with a fall during the late Mrs Richards' time in Gosport hospital when she dislocated her hip - ie after the original fall in the nursing home which led to the hip fracture in the first place and admission to Haslar hospital for that.

I think Mrs Mackenzie is relating the administration of chlorpromazine and some subsequent event relating to that disclocation of the hip during the stay in Gosport hospital which necessitated the return to Haslar for the further operation. She thinks the treatment with the tranquillizer was inappropriate and is asking that both those witnesses be called.

The issue that has caused her a lot of agitation is having to set back the hearing date of 17 September. She had been okay with that date but "hit the roof" this time round!

I just wonder if fixing a new date is the top priority and then after that you might consider if the evidence of these two nurses, Brewer and Baldochino, assists you or not. I am quite anxious to get the hearing date fixed. We have sent back availabilities for the autumn 2012 and for January 2013 as a fall back too.
