Thank you for contacting me about the Gosport War Memorial Hospital. As I am sure you are aware I became MP for Gosport in 2010 and much of the Gosport War Memorial Case had long since passed, although as a local person I obviously know the background of the case. I realise that for you and others in your position it is very personal indeed and the emotions are still very raw.

At this stage we are waiting for the long overdue Coroner's Inquest to convene and I will be taking a close interest there. I was also alerted to the fact that the mortality rates for GWM Hospital had not been published and although the content has been shared by several health organisations and Hampshire Constabulary that information has not been made public. I have therefore raised a question with the Secretary of State for Health to let me know when that information will be made public. I am waiting for his response. These are areas I can help with and I will continue to do so.

I am writing once again, to request your help in at long last getting the release of the audit of deaths at the Gosport war memorial hospital during the 1990's under Jane Barton and her medical team. The report was prepared by Professor Richard Baker in what became known as 'The Baker Report' and, whilst being seen by the all government bodies, quangos and official organisations has still been withheld from both the relatives and public by this 'so-called' transparent government.

Given Cameron's comments of late over the mid-staff nhs scandal and the fact that so many other health trusts are under investigation because of their high death rates it seems wrong that the death rates for the war memorial are still being withheld.

I do not believe that the inquest into Gillian McKenzie's mother's case is a good enough excuse to still withhold this report. In fact I actually believe that if there is 'any justice', (I've no faith in either the justice system or the coroner), that at the inquest of her mother, if they ever stop putting it off, and a jury are freely able to decide, they would return a verdict of un-lawful killing.

Cameron has said that it was "not acceptable" for NHS chiefs to avoid responsibility for scandals such as Mid Staffordshire, where 1,200 patients died needlessly, he further said managers must face "proper accountability" when people were found to have died of neglect.

My father didn't die of neglect,he was overdosed and murdered, as were many others. Where exactly does the PM stand on this one. we've never even had an apology let alone accountability.

If i can remind you, in my fathers case the inquest jury ruled that the that drugs had contributed to his death. At the GMC they ruled that in my fathers case the 'doctor' was guilty of gross professional misconduct and that not only were the drugs not appropriate but that they had also contributed to his death.

No prosecution, no court case, no nothing really and then able to retire on her full pension..... Very accountable..

And what of the hospital trust and the health trust??? Be very nice to see some accountability....

My Dad deserves justice, he was a hero of the Artic convoys, a cause I know close to your own heart, he was a hero on D.Day (his worst nightmare!!) and he was involved in SBS missions, he was a true hero..especially to me... he didn't deserve to die this way!!

Your government state that they are transparent please help me make them be transparent over the killing of my Dad and at last release the death figures behind this scandal.

I haven't been in touch of late not because I had given up but rather I have spent the last few years effectively gagged by the CPS and Gosport police.

I was wrongly arrested and charged with a racially motivated assault, at the magistrates court I was refused legal representation and was then found guilty, it then took almost 3 years to fight the allegations in the appeal court, only for the hearing to collapse when the prosecution's star independent witness broke down and admitted that he had not witnessed anything as he was not there and had lied to help his friend, who is a drug dealing taxi driver that appears to be protected by gosport police.

However this fact was also kept from me at the court hearing and I only found out following the witnesses appearance in court at the end of last year charged with perjury and perverting the course of justice for which he received a suspended prison sentence and un paid community work.

The cps and police both used this incident against me in that to most requests i would get the response that they were not able to deal with me whilst 'other matters' were outstanding.

Now i understand the cps have closed the case on my father and apparently destroyed the files !!! If that is so it stinks of a cover up!!

I have taken some hope from the results of recent enquiry's specifically the mid staff and hillsbrough ones, in mid staff we might just start to see those guilty being held to account, and at hillsbrough it was accepted that police lied and perverted the course of justice in order to cover up their failings.

I have always alleged that this is the case here, senior officers have perverted the course of justice in order to cover up the incompetent shoddy manner of their original handling of this investigation.

I now know that 10 days before my father was admitted to the war memorial another relative had been to gosport police to lodge a complaint against the doctor and nursing staff alleging the murder of her mother, this lady would not have minced her words and with what i now know to be her vast knowledge would have stated her case very clearly. The police did nothing!!!

Had they taken this Lady's allegations seriously and acted on them, there is no way that my father would have been transferred to the hospital because the police should have been investigating, instead they did nothing.

And this is why I hold Hampshire constabulary and gosport police entirely responsible for the death of my father, there failings put why father at risk....

I know that this is probably the least popular cause in gosport for you to put your name to, I myself have had two councillors that have told me I've brought a bad name to the town because of the war memorial, but my dad and all those others deserve justice please help us all get that.
