Thank you for your letter of 13 February to John Reid regarding the time limits for medical enquiries and the ongoing investigation into deaths at Gosport War Memorial Hospital. Your letter has been passed to me as the Minister responsible for health services in the south of England.

You refer to a recent announcement by the Department that all medical enquiries should be completed within two months.

I believe that you are referring to a time limit set out in the draft regulations on the reformed NHS complaints procedure that were published on 17 December last year for consultation. The time limit (40 working days) is one for the new Commission for Healthcare Audit and Inspection (CHAI) to complete the report of its investigation of a complaint. CHAI has also published a consultation document on its proposals for the handling of complaints, which talks about completing the report of an investigation within two months of the request for independent review. I should point out that this proposed time limit is not one for completing the whole complaints process, which will, of course, include an attempt to resolve matters locally first (local resolution).

The draft regulations also deal with the time limit for responding to a complaint at local resolution. However, as I mentioned, this is currently subject to consultation and so the time limits are not yet fixed. The intention is to implement the reformed complaints procedure from 1 June this year. Turning to the concerns you have raised about the investigations into deaths at Gosport War Memorial Hospital. As you are aware, there is a ongoing police inquiry into the past care and treatment of patients at the Hospital and it is not appropriate for me to comment on this. However, I am assured that the NHS in Hampshire and the Isle of White has co-operated fully with Hampshire Constabulary during the investigation and will continue to do so.



I also understand that the Hampshire police are keeping the families fully informed of how their investigation is going at every stage.

I hope this addresses the points you have raised.
