As I respond to your invitation to attend the inquest of Mr Leslie Pink on Thursday 3 December may I take this opportunity to correct a typographical error in the letter that I wrote to your officer on 12 January 2009. I note that I saw Mr Pink on 17 October 2008 in the surgery with painful varicose eczema. This is not correct, I actually saw him on 17 December 2008 in a duty triage surgery and at the same time he was seen by one of my Practice Nurses. I noted in my entry in his clinical notes that he was suffering from varicose eczema in both legs. This was not infected but itchy and his veins were prominent. I prescribed a steroid cream and some support stockings in consultation with the Practice Nurse.

The next entry in his clinical notes is 23 December when he was seen at home by a partner by which time he had pain in his left hip and problems getting up from his chair which led onto an admission to Queen Alexandra Hospital on that day.

I do apologise for this inaccuracy in my original letter and I hope that this clarifies the situation for you somewhat.
