According to the Independent on Sunday, NHS whistleblowers are routinely gagged in order to cover up dangerous and even dishonest practices that could attract bad publicity and damage a hospital's reputation. An organisation called Public Concern at Work has said that two thirds of doctors and health workers are accepting non disclosure clauses in their contracts. The article mentions the GMC in a side box about Dr Shiban Ahmed, a paediatrician from the North Staffordshire hospital who has been suspended since March after raising the alarm about errors in children's operations. It says he complained for months to the GMC and BMA. An editorial accompanying the article says that gagging clauses should be outlawed by the Public Interest Disclosures Act but that whistleblowers are understandably reluctant to test this in court.

An article in The Mail on Sunday reports that Dr Gary Horn made serious errors when operating as a cosmetic surgeon as part of the Harley Street Medical Group. Patient Sarah Cound was left permanently disfigured by a breast reduction operation performed by the doctor. The article says that according to GMC records the doctor trained in France and at the time of the operation was listed as a 'General Surgeon'. It says that the GMC took no disciplinary action was taken against the doctor.
