- Calderdale Evening Courier reports on the death of Dr Ann Christine Evans and notes that she was a specialist adviser to the GMC.
- The Yorkshire Post claims that over £1million has been paid to suspended NHS staff in Yorkshire, including 20 excluded hospital doctors and GPs. A response from Leeds hospitals mentions that regulatory processes have to be followed and mentions the GMC.

- An article on peer review refers to the Lancet article on the MMR vaccine by Code A and the subsequent FTP case in which he was found guilty of serious professional misconduct in January.
- A From the Frontline column by Dr Des Spence says that the GMC should take the lead on a properly enforced national register of conflicts of interest for all doctors to help protect the profession.
- An article states that the GMC has had to disclose documents relating to former panellist Mr Brightmore, who
 was dismissed as a panellist for not disclosing the extent of his links with the Church of Scientology. The
 article notes that the GMC has written to 70 doctors where Mr Brightmore was involved in their cases telling
 them he had his contract as a panellist terminated in 2004.
- A Cath Janes an article on terminating your contact with a difficult patient says that the GMC advises that doctors should be prepared to justify their decision to remove a patient from their GP list.
- An article by Swayamjyoti Ray on the use of role models in teaching doctors and students highlights the six sets of behaviours the GMC has outlined in what she refers to as the 'Duties of a Doctor' publication from 2006.

 Reports that Dr Clare Gerada has been elected the first female chair of the Royal College of General Practitioners in 50 years. Dr Gerada will replace Code A in November 2010.

Fitness to Practise:

- Dr Abdul-Salam South Wales Argus reports that Shiree Hanbury, mother of nine-month old Aleesha Evans who died after being sent home from hospital by Dr Abdul-Salam, has claimed that the four month suspension given by a GMC FTP Panel is insulting and robs her of justice. The paper's editorial column highlights its support for Ms Hanbury.
- Dr Jane Barton -, NHS Hampshire has confirmed in the Southern Daily Echo that Dr Jane Barton, who was found guilty of serious professional misconduct by a GMC FTP Panel, has now retired from practice. It highlights that the case against Dr Barton was brought following an investigation into the deaths of 12 patients at Gosport War Memorial Hospital between 1996 and 1999.
- Dr Joe Motwani The Daily Telegraph, Western Morning News and Plymouth Herald report that Dr Joe Motwani
 faces being struck off by the GMC following a review of interventional cardiology procedures at Derriford Hospital

between 2001 and 2007. The story in the *Plymouth Herald* notes the GMC release stating the charges and that the FTP Panel will commence in June.

• Dr Alistair Waygood - The Herald reports that Dr Waygood has been struck off the GP register after a Panel decided his fitness to practise was impaired 'by reason of misconduct, cautions for criminal offences and adverse physical or mental health'. The story states that the police cautions were for drunken and disorderly behaviour.

The checklists require that doctors or nurses to sign to say they had carried out certain treatments. For example, the checklist for chronic obstructive pulmonary disease said patients should be given a chest X-ray within four hours of admission to hospital. Some lists required staff to confirm that they had washed their hands. The lists were introduced in three hospitals run by The North West London Hospitals NHS Trust and developed for a number of serious conditions, including strokes and heart failure, and the study found that death rates had fallen by 14.5 per cent after the lists were introduced.
