BMA News (21 Mar 09)

- An article, placed by the GMC's media team, about the BMA praising the GMC's decision to give consultants a second chance to join the specialist register quotes Neil Roberts, GMC Director of Registration & Resources as saying: "Entry on to the specialist register will allow these doctors to participate in recertification".
- A feature article looking at the experiences of two Polish doctors who have come to work in the NHS quotes GMC registration figures on how many Polish doctors have joined the register since before and after Poland joined the EU in 2004.
- A letter in response to an earlier article about the doctor's responsibility in uncertain and complex situations, mentions the GMC's *Consent* guidance, in relation to a patient refusing treatment. The author notes that, only when doctor's face such decisions pro-actively can such matters be acted on in the patient's best interests.

BMJ (21 Mar 09)

- There is a brief news item about the GMC opening up the Specialist Register for those consultants not already entered on to it.
- There is an article about Lord Laming's report into child protection and how the wariness of health and social care staff to engage with this must be addressed. The article mentions the high profile GMC fitness to practise cases of Professor Roy Meadow and <u>Code A</u> as contributing to paediatrician's being unwilling to undertake child protection work. It also mentions that Baby P's doctors <u>Code A</u> and Jerome Ikwueke are registered with sanctions pending investigations.
- An article and an editorial about the nominations for the new Chair of the GMC focus on one not being a
 doctor and how this news could be vieweed positively and negatively. They ask for readers opinions on the
 matter.
- There is also an article announcing the chairs of three new boards (undergraduate, post-graduate and continued practice).
- A newshound piece notes that Remedy UK are only £1,500 away form raising the required amount for a legal challenge against the GMC.
- There is also a mention of the GMC's guidance around medical students' fitness to practise, placed by the media team.

The Lancet (21 Mar 09)

• The editorial comments on the two pieces of guidance recently issued by the GMC in relation to medical students fitness to practise and the revision of *Tomorrow's Doctors*, currently out for consultation. Although the comment agrees with the importance of such guidance, it notes that the quantity of so many requirements means that the "...relative merit of each point is lost, as is the broader goal of education". The comment

concludes that the GMC should promote "...enthusiasm and ideals, foster compassion and kindle a spirit of scientific enquiry".

 Although it does not mention the GMC, a lengthy article on professional ethics asks why these codes can sometimes fail. In summation, the article concludes that there are many different codes of ethics, at varying levels and they all differ.

The *Daily Mail* covers the fitness to practise hearing of Dr Silvia Baciu, who made racist comments towards Asian colleagues (suspended for six months).

The *Daily Telegraph* also mentions the fitness to practise review hearing of Dr Peter Windross (posession of ecstasy; the doctor has been allowed to practise again).

The News mentions the inquest into deaths at Gosport War Memorial Hospital and that Dr Jane Barton, the only doctor named during initial investigations some years ago, is currently subject to GMC restrictions on her registration.

The Guardian interviews the parents of young people about how the medical system is not protecting children. The mother of a boy who died at the Bristol Royal Infirmary in 1986 notes that "...there needs to be a competent authority and not doctors overseeing themselves. The GMC remit is too narrow".

Other News

There are further mentions and comments on former Health Secretary Patricia Hewitt's call for a change in the law on assisted suicide in the national press.

Broadcaster John Humphrey's talks about how the death of his father convinced him that assisted suicide can sometimes be the correct death for certain people (*Daily Mail*).
