Sir

On the 27/06/2004 I spoke with Michael ROBINSON the nephew of Rhoda Ethel Daisy MARSHALL 30/06/1911 - 07/01/1996.

Mr ROBINSON was the primary carer for his aunt who he describes as his maiden aunt. She was born and lived in the Portsmouth area, she never married and had no children. She was one of five siblings a further two died at childbirth. All the other siblings including Mr ROBINSON's mother have now died.

Rhoda worked as a corset maker and did not suffer from any known injury or illness during the early part of her life. As she got older she went and lived with her sister Mrs Ethel ROBINSON, Mr ROBINSON's mother. In October 1990 Mrs ROBINSON died and Rhoda went to live at a rest home, Headley House in Farlington, Portsmouth. During her time there she was happy and well cared for.

Code A She was admitted to the Queen Alexandra Hospital for a period of about two weeks. Mr ROBINSON visited her during this time and although she was in pain she was able to talk. Close to Christmas Rhoda was moved to the GWMH. Initially Mr ROBINSON had no concerns, he would make regular visits seeing her 2-3 times a week.

On the 07/01/1996 Mr ROBINSON visited his aunt at about 1130 hours. This time there was a marked decline in her well being. Mr ROBINSON did not immediately recognise his aunt and the weight loss was described as profound. Her breathing was laboured and she is described as being totally out of it. She died later that day. The cause of death is shown a **Code A** and the certificate was signed by Dr BARTON. Rhoda was cremated.

The family have always had concerns over Rhoda's death. They fully expected her to come out of the GWMH, they were never updated by staff and feel her decline was very sudden. They have asked to be updated with bulletins.




