Dear Mr Farthing,

I hope you'll appreciate that I'm not in a position to give you that advice.

As I explained, we did try very hard in the public inquiry direction but without any success, despite a face-to-face meeting at the Ministry of Justice in London. The reason for the refusal was that there were no matters of national importance involved.

Prior to that, I tried to pursue with the CPS why no prosecutions were being undertaken in respect of the Gosport deaths. I understand the CPS decided not to prosecute on the advice of leading Counsel. I did ask the CPS for sight of Counsel's advice on a number of occasions but they declined to let me see it. There was nothing I was able to do about this as a Coroner has no legal power to force the CPS to divulge this sort of information.

If you consider it worthwhile pursuing matters along the lines of what you say in your email, that is for you to decide and I have no objection to your doing so.

Thank you for your reply which falls well short of my expectations.

With all due respect, I am aware that Inquests are not a Public Enquiry, and fully understand that it is your duty to decide the cause of death only, assisted by a jury as deemed appropriate. However, you need to be aware that Mr Cunningham's death was one of five that were thoroughly investigated at <a href="mailto:an early stage">an early stage</a> by Dr K Mundy and Prof G Ford under the auspices of Inspector James of Hampshire Police, and that their reports formed the basis for the subsequent damning assessment by the Commission for Health Improvement.

I therefore feel very strongly, that these reports form a vital element in establishing the true cause of death, something that can never be properly determined without full information being available to the jury. It has been patently clear for some time that a blatant cover-up has been perpetrated by the various authorities involved, and I am afraid that that situation will continue unless the information previously requested by me is released.

I am aware also that you have the authority to direct the various agencies to make all information available in order for a correct decision to be made, and would ask for re-consideration of my request as the information provided thus far is incomplete, inadequate and **could very well be misleading** if the full picture is not visible.

On the question of a Public Enquiry, I would also ask if this was ever considered to be a more appropriate way forward, and why it is that that course is not being pursued now??
