Information on how we use our powers under section 29 of the NHS Reform and Health Care Professions Act 2002 can be found here: CHRE FTP decisions .

Today we have issued the following press release about Dr Jane Barton:

'Following the decision made today by the GMC's Fitness to Practise Panel to impose conditions on Dr Jane Barton, CHRE has called for the transcripts of the case. We will review those transcripts and the decisions made. CHRE has power to refer the case to the High Court if we consider the decision by the panel to be unduly lenient and that is necessary for the protection of the public. We will announce our decision in due course.'

If we are to appeal the decision, our legislation sets out that we must do so within 40 days of the last date of which the registrant can appeal.
