Hi Briony

We have heard back from Martin Chamberlain's clerk and he does not have capacity. We therefore checked with Peter Mant's clerk and Peter would be available and would like to do it. He estimates that it would take 3-4 weeks. Peter's standard hourly rate is £125 per hour but the clerk did say this was negotiable. I would have thought we could agree a fixed fee for the advice of perhaps £15,000.
