Peter Mant has sent us his advice on the Barton matter, and his conclusion is that the Panel's decision to impose conditions on Dr Barton rather than suspending her, was not unduly lenient. As agreed last week, we will produce a lawyer's report based on his advice, and send both to you for your review ahead of the case meeting.

In the meantime, Peter has asked that we follow up with you on one point. He would like a copy of the interim order that was granted by the Interim Orders Panel imposing restrictions on Dr Barton's ability to prescribe certain medication.
