I am presently employed by Portsmouth Hospitals National Health Service Trust as a Consultant Nephrologist and Physician and have been since December 1995. As such I am responsible for the care, treatment of out patients and in patients with kidney problems at the Queen Alexandra Hospital, Portsmouth. In September 2002 the department transferred to the QA Hospital having previously been based at St Mary's Hospital. There are six consultants in the renal team who supervise a constantly changing number of registrars and senior house officers. At the present time there are six registrars and six SHO.

In 1999 the renal team was based at St Mary's Hospital, the structure of the team was the same although with few people. I believe that at that time there were only four consultants.

I qualified at Newcastle upon Tyne University in 1981 gaining a MBBS, Bachelor of Medicine and

Bachelor of Surgery degree. On gaining my qualification I worked in the Newcastle area as a pre-

registration house officer and then a senior house officer from 1981 to 1985. During this period I sat

and passed exams for a MRCP, a Member of the Royal College of Physicians - 1984.

That then allows you to become a registrar which I did in 1985 becoming a registrar in London. I did

a two year rotation in London working at the West Middlesex and Charing Cross Hospitals. Then I

went to Hammersmith Hospital for two years doing clinical and laboratory research. The research

resulted in an award of an MD (Doctor of Medicine) from Newcastle upon Tyne, that was awarded in

1991. I finished the research post at the end of 1989 but the degree was not awarded until 1991 as it

had to be finally assessed.

From 1990 to 1992 I worked in Adelaide, South Australia as a registrar in Nephrology (kidney

disease). When I finished in Adelaide I took various locum jobs, short term employments, in

different hospitals within the UK until February 1994. I was employed by Portsmouth NHS in 1994

as a senior registrar working at St Mary's Hospital until I was appointed as a consultant in 1995.

In 1999 I was responsible for my own case load, ie, patients, there was a consultant who had overall

charge of the department but that was for administration, he would have been involved in the

departments finances and planning for the future. He was referred to as an Associate Clinical

Director but did not supervise my work or the care or treatment of my patients.

At that time patient referrals would come from GP's or other consultants. We ran out patient clinics

at St Mary's where the patients were seen. It is recommended that new patients are seen on their

initial visit by the consultant. I ran my clinic with a senior house officer and a registrar and would

allow one of these members of staff to see the patient initially. This was for training purposes, when

they had seen the patient I would introduce myself to the patient and supervise the investigation and

management of the patient's complaint.

I have been asked to comment upon the care and treatment of Elsie DEVINE. I have no personal

recollection of this patient but from her medical notes and letters I can say that:
